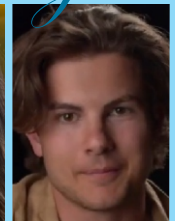

Early Bird Registration, including payment, MUST be received by May 31, 2025. If payment is not received by May 31, the full registration price will be required.

PLEASE NOTE:

Due to many non-refundable upfront expenses, we are implementing the following cancellation policy: 50% REFUND on cancellations prior to June 15, 2025. NO REFUND after June 15, 2025.

(At the sole discretion of CFM, exceptions will be considered for extraordinary circumstances.)

All Vendor Representatives are required to register for the Catholic Family Life Conference. This allows access to all conference activities and events throughout the conference weekend. You must be registered, including full payment, by May 31 for Early Bird Pricing. On June 1st, full pricing applies.

Upon verification of registration and receipt of payment, you will be added to our conference vendor list. CFM reserves the right to limit materials made available for viewing or distribution. Materials must be pre-approved by CFM prior to registration and CFM retains sole discretion to request the removal of any vendor materials. Vendors not immediately complying with such request will be asked to leave the conference. **Fees will not be refunded.** (Space may be limited. **Register early to ensure participation.**)

PLEASE NOTE

1. Food and Accommodation: All Vendors are responsible for their own food and accommodations at the conference.

2. Vendor Materials: Lake proximity can result in high humidity. Bring protection for your materials. CFM is not responsible for providing covers, drapes, etc. OR any damage to materials.

3. Exhibit Space: Tables are six feet and Vendors are allowed a maximum of three tables. If you require electricity, please register early to ensure availability. Cords or accessories are NOT provided.

4. PARKING: Other than for set-up and take-down purposes, there is NO parking beside the Vendors Tent. This area is an emergency access route so vehicles left by the Vendor Tent will be towed at the Vendor's expense. Parking is available on the grass strip on the south side of the Cemetery.

5. Registration Packages: We will include vendor handouts, announcements, etc. in the conference registration package. Insertion cost is **\$100 per item** with an additional charge for extra items. Package inserts **must be received by June 15.**

6. FREE SPACE is available, but very limited. This space is for non-profit and awareness purposes. (Unmanned and no sales)
